INFORMATION NOTICE

As **SARSILMAZ SİLAH SAN. A.Ş.** (hereinafter referred to as "SARSILMAZ"), we respect and value the privacy of individuals. Therefore, we would like to inform you about your rights regarding the use and protection of your personal data within the scope of the Law on the Protection of Personal Data No. 6698 (hereinafter referred to as "KVKK").

As SARSILMAZ, in our capacity as the data controller, your personal data will be processed based on the legal ground stated in Article 5, Paragraph 2(f) of the KVKK, which allows processing of data for the legitimate interests of the data controller without harming the fundamental rights and freedoms of the relevant person, for the following purposes: execution of customer service processes; management of customer relationships; handling customer complaints; managing activities aimed at customer satisfaction; establishing and enhancing customer loyalty to the company's services; conducting identity verification activities; providing customer-specific products and services; carrying out customer service activities via internet and mobile channels; and recording notifications such as complaints, objections, requests, suggestions, and satisfaction in our notification management system to provide you with better service. As the data subject, we hereby inform you that you have the following rights under Article 11 of the Law:

- To learn whether your personal data is being processed,
- To request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether it is being used in accordance with that purpose,
- To be informed of third parties to whom your personal data is transferred, either domestically or abroad,
- To request the correction of your personal data if it has been processed incompletely or inaccurately,
- To request the deletion or destruction of your personal data within the framework of the conditions set forth in the relevant legislation,
- To request that the correction, deletion, or destruction of your personal data be communicated to third parties to whom your personal data has been shared,
- To object to the emergence of any outcome against you through the exclusive analysis of your personal data by automatic systems,

• To request compensation in case you suffer damage due to the unlawful processing of your personal data.

With regard to your requests concerning these rights under Article 11 of the KVKK, by completing all the information specified in the Data Subject Application Form, in accordance with Articles 11 and 13, Paragraph 1 of the KVKK and the Communiqué on the Procedure and Principles of Application to the Data Controller,
